



a. Make sure the device in the package is in good condition and all the assembly parts are included.b. Check the product specification for the installation environment.




The table bracket is suitable for indoor stations with both 7-inch screen and 10.1-inch screen.

Installation

- 1. Put the table bracket on the desk.
- 2. Route the cable through the cable hole to connect the indoor station.
- 3. Hook the indoor station to the table bracket tightly by inserting the table bracket hooks into the slot on the rear panel of the indoor station, during which the lock catch will be locked automatically.
